

## **Privacy Policy**

Awards Media Group Inc is part of the Company Group that operates under the brand name Agency of Internet Rights (AIR). This Privacy Policy will explain how Awards Media Group Inc (hereinafter referred to as “we”, “our”, “us”, “Our Company”) uses the personal data we collect from you when you register at our website <https://im.air.io/> (hereinafter referred to as “Website”) to take part in our online events, such as webinars, conferences, seminars or classes for video bloggers (hereinafter referred to as “Online events” or “Services”).

### **What data do we collect?**

Our Company collects the following data:

- Your Name
- Electronic address
- Telephone number
- Your YouTube Channel web address

### **How do we collect your data?**

You directly provide Our Company with the data we collect. We collect data and process data when you:

- Register online to take part in our Online events;
- Use or view our website via your browser’s cookies.

### **How will we use your data?**

Our Company collects your data so that we can:

- Register your account on our Website;
- Allow you to take part in Online events;
- Allow you to get access to materials related to the events than you might like;
- Process your orders and manage your account on our Website;
- Inform you of special offers on products and services we think you might like.

In addition, Our Company will share your data, for the purposes set out above, with partner companies that are part of the Company Group that operates under the brand name Agency of Internet Rights (AIR), if they are involved in providing Services.

Our lawful reason for processing your personal data is your consent. You are not obliged to provide us with your personal data. However, failure to provide us with your personal data will prevent us from providing to you our Services that require online registration. Your personal data will be processed based on Regulation (EU) 2016/679 (General Data Protection Regulation).

### **How do we store your data?**

Our Company securely stores your data in our servers, located in the EU and outside the EU. When storing your data, we take all necessary measures to protect it from third-party access.

Our Company will keep your personal data for the purposes set out above as long as we are likely to use it, unless you ask us to delete it. We will regularly delete data which we believe is no longer accurate or up to date.

### **Marketing**

Our Company would like to send you information or contact you about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

### **What are your data protection rights?**

Our Company would like to make sure you are fully aware of all of your data protection rights. You are entitled to the following:

**The right to access** – You have the right to request from Our Company copies of your personal data.

**The right to rectification** – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request that Our Company complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that Our Company erase your personal data.

**The right to restrict processing** – You have the right to request that Our Company restrict the processing of your personal data.

**The right to object to processing** – You have the right to object to Our Company's processing of your personal data.

**The right to data portability** – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you.

**The right to withdraw your consent** – You have the right to withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.
